

# Toutle Lake School District

## Internet User Access Individual Release Form

As a condition of my right to use computers located on Toutle Lake School District properties and to access the Washington Education Network, (K-20), including use to access public networks such as Internet, I understand and agree with the following:

1. The use of the (K-20), , including use to access public networks, is a privilege which may be revoked by Toutle Lake Schools, their representatives or other administrators of the K-20 network at any time for abusive conduct or violation of the conditions of use set forth herein or in the Access Policy.

a) Abusive conduct includes but is not limited to, the placing or transmission of unlawful information on the network, the improper access, misappropriation or misuse of information/files of other users, and the use of obscene, abusive or otherwise offensive or objectionable language in either public or private messages. Access structure shall not be altered in any manner through the addition of software, external hardware devices or connections. Toutle Lake School District staff or their representatives will be the sole arbiter(s) of what constitutes abusive conduct or violation of this Acceptable Use Policy.

b) Toutle Lake School District staff have the right to review any material stored in files to which other users have access and to actively filter, edit, block access to or remove any material which they, in their sole discretion, believe may be unlawful, obscene, abusive, or otherwise objectionable and I hereby waive any right of privacy which I may otherwise have in and to such material.

c) All information and services contained in workstations on Toutle Lake School District properties are placed there for general informational purposes and are, in no way, intended to refer to, or be applicable to, any specific person, case, cause or situation.

2. Toutle Lake School District will not be liable for any direct or indirect incidental or consequential damages due to information gained and/or obtained via use of the (K-20) to access other public networks including the internet.

a) The user, assumes full financial liability up to the sum of \$2500.00 for the cost of repairs to or replacement of the hardware and/or software used by Toutle Lake School District to provide access to (K-20), or any of the public networks therein contained, should it be damaged by improper use, including without limitation, personnel time required to reformat and restructure access from Toutle Lake Schools.

b) Toutle Lake School District does not warrant that the functions of the K-20 network or any of the networks accessible through the K-20 network will meet any specific requirements students may have, or that the access will be error free or uninterrupted; nor the District be liable for any direct or indirect, incidental, or consequential damages (including transient embarrassment, lost data, information or profits) sustained or incurred in connection with the use, operation or inability to use the K-20 network.

3. To abide by such rules and regulations of usage as may be promulgated from time to time by Toutle Lake School District staff or other administrators the K-20 network including, without limitation User Access Agreement by Board Policy, the current release of which is encapsulated hereto.

In consideration for the privilege of using the K-20 network and in consideration for having access to the public networks, I hereby release Toutle Lake School District, its operators and any institutions with which they are affiliated from any and all claims and damages of any nature arising from my use, or inability to use, the K-20 network including, without limitation, the type of damages identified in Paragraphs 4 and 5 above.
